2025 Executive Elections and Electronic Voting Information

All voting for the upcoming 2025 Annual **Executive Board Elections will be conducted** online.

There will be an election for President, 2nd Vice President, City Sector Representative, K-12 Sector Representative, HSSCBA (Community) Sector Representative. The Park Board Sector Representative and Trustee positions have been filled by acclamation.

You will receive voting instructions and a Personal Identification Number (PIN) in the mail. This PIN will allow you to cast your vote for the candidate in your sector, as well as the table officer (President and 2nd Vice President) positions.

Voting will open by electronic ballot at 8:00 a.m. Pacific Standard Time on May 20, 2025 and will remain open until 11:59 p.m. on May 27, 2025. Polls will be accessible 24 hours a day. Results will be announced at the Annual General Meeting, which convenes at 5:30 p.m. on May 28, 2025 via Zoom.

Simply Voting has been hired as the independent third-party election provider. All PIN issuance and voting is maintained and monitored by them.

If you do not receive a PIN in the mail, please contact the union office and after verification of your membership, we will instruct Simply Voting to send you one. The deadline to request a PIN is 12:00 noon on May 26, 2025. No exceptions.






EXECUTIVE UPDATES



Time to Stand Together

With uncertainty in Canada-U.S. relations and a federal election on the horizon, it is more important than ever that we stay engaged and active in

our union.

We have been busy forming working committees to tackle key issues, including Long-Term Disability, Reclassifications, Contracting In, and Conversion for our City and Park Board members.

Your 1st Vice President (and recent Acting Secretary-Treasurer) Santino Scardillo, and I have been working closely with local union presidents across the metro region to explore the possibility of a municipal LTD plan. I am happy to share that there is strong interest from our counterparts in the region.

With support from our National Servicing Representative, the Municipal Coordinator, and CUPE Local 15 staff, we are working toward a plan that makes financial sense for both our members and the employers. We will be sure to keep you updated as things progress.

We have also been pushing forward on converting auxiliary positions into Regular Part-Time (RPT) and Regular Full-Time (RFT) positions to ensure more job stability for our members.

On another front, we have recently formed a Reclassification Committee to help members who believe their positions should be reclassified. The purpose of this committee is to simplify the process and provide the support needed to build strong cases for reclassification.

Bargaining is another critical time when we need to stand together. Many of our sectors are either getting ready to negotiate or have already started meeting with employers.

In the provincial sector, bargaining committees representing Vancouver Coastal Health (HSSCBA and HSPBA), the Vancouver School Board, Langara College, and Emily Carr University are working on proposals or have already ratified them with members and are preparing for negotiations.

Meanwhile, in the municipal sector, our members at RayCam, Britannia, Parks, and the City have ratified their proposals and are now in discussions with the employer.

I want to thank our 1st Vice President, Santino Scardillo, for acting in the role of Secretary-Treasurer during Debbie Mohabir's leave. Santino's continued dedication to the members of CUPE Local 15 is greatly appreciated.

I also want to thank our stewards, staff, working committee members, and our Society and Executive Board members for all the work they have done and continue to do in support of our members.

Let us continue to stand together in these uncertain times.

Remembering and honouring workers on April 28th

The National Day of Mourning is a day to remember workplace tragedies and honour CUPE members, and all workers, who have lost their lives or been injured at work.

Our union represents members in both inside and outside worksites, each with unique workplace environments. Our commitment,

as a union, is to ensure that all our worksites have an Occupational Health and Safety (OH&S) committee in place. If your workplace does not have an OH&S committee, please contact the union office. It is your right to have a worker representative on-site to report safety concerns.

We can support each other in the workplace by reporting any unsafe conditions to the employer. If the issue is not resolved, it should be brought to the union's health and safety committee, which will escalate it to the central health and safety committee (comprised of both employer and union representatives).

Always remember that you have the right to refuse unsafe work. If you see something unsafe, you have a responsibility to report it. This helps ensure that everyone is aware of potential hazards and prevents injuries.

We look out for each other because we all want to go home safely to our loved ones at the end of the day.

On another note, working in the union office as Acting Secretary-Treasurer during Debbie Mohabir's leave has been a great experience. Even after all my years serving on the Executive Board, there was still a learning

OH&S CORNER

National Day of Mourning – April 28th

Since the beginning of Canadian Confederation in 1867, workers have faced challenging and, at times, dangerous work conditions that have resulted in injuries and workers' lives lost. By the time the transcontinental railway was completed by Canadian Pacific Railway in 1885, it is estimated that up to 4,000 railway workers, mostly of Chinese descent, lost their lives. On June 17, 1958, 19 workers lost their lives while building the Ironworkers Memorial Bridge (Second Narrows Bridge) that connects Vancouver and North Vancouver.

More recently, the Association of Workers' Compensation Boards of Canada recorded 1,057 workplace deaths across Canada in 2023, many of whom were young workers. In 1991, eight years after the Canadian Labour Congress initiated a day or remembrance for workers, the Parliament of Canada passed the Workers Mourning Day Act making April 28th an official National Day of Mourning for workers.



While unions throughout Canada and globally have fought for improved workplace safety considerations, many of us continue to have friends and co-workers who have died or suffered serious injury at work. If you have current concerns about safety issues in your workplace, please understand your right to refuse unsafe work and be involved in workplace safety decisions. You can do this by connecting with your worksite Occupational Health and Safety Health Committee representatives or by contacting the CUPE Local 15 office.

As the Canadian Centre for Occupational Health and Safety (CCOHS) urges us: "We remember workers who have died, were injured, or became ill from their job. We commit to protecting workers and preventing further workplace tragedies." Please take time throughout your day to be mindful of workplace safety while we mourn those we have lost or have been injured. On April 28th at 11:00 a.m., please observe a moment of silence for those we remember and mourn. Mourn, remember, and prepare for workplace safety!

ON MARCH 8, 2025, THE VANCOUVER DISTRICT LABOUR COUNCIL (VDLC) WOMEN & GENDER RIGHTS COMMITTEE HOSTED AN INTERNATIONAL WOMEN'S DAY (IWD) DINNER UNDER THE THEME VOICES OF POWER – WOMEN TAKING POLITICAL ACTION AT THE SOUTH HALL EVENT CENTRE.

This event celebrated women's achievements in the workforce and reinforced their essential role in driving political and social change.

Upon arrival, the welcoming atmosphere was immediately apparent. After a chilly walk from the bus stop, I entered a warm and lively room full of passionate labour activists. The VDLC Women & Gender Rights Committee had brought together a diverse group of labour communities. The event was well-organized, with food served buffet-style, allowing everyone to mingle. The meal was abundant, setting the tone for an evening of meaningful discussion and solidarity.

A memorable moment was the performance of Bread and Roses. Led by a talented vocalist and accompanied by acoustic guitar, we stood together and sang, reinforcing our unity.

The evening began with a powerful welcome from Spelex ilh Anjeanette Dawson, an Indigenous educator, traditional wool weaver, knowledge keeper, and BCGEU's Indigenous Education Officer. She dressed the stage with wool weavings, furs, and significant baskets, each holding cultural meaning. Dawson shared a slideshow detailing the labour history of First Nations people on the coast.

The panel discussion was moderated by Karen Ranalletta, President of CUPE BC and Yukon. The panel featured influential women in political leadership, each offering a distinct perspective on how women can drive societal change. Jenny Kwan, MP for Vancouver East, spoke passionately about the need for political action, urging attendees to rise up and take their place in decision-making processes. Kwan's words resonated with the crowd, emphasizing the importance of political engagement and standing firm in adversity.

Niki Sharma, Deputy Premier of BC, shared her experiences as a woman from rural BC. Wearing a Woman of the Global Majority T-shirt, she spoke about embodying the change one wants to see. Her presentation inspired many, emphasizing her commitment to creating transformative change at the provincial level.

Jennifer Reddy, Vancouver School Board Trustee, reflected on her six years of service, discussing the importance of addressing issues head-on and the success of minority governments in achieving progress through cross-pollination.

Christine Boyle, Minister of Indigenous Relations and Reconciliation, spoke passionately about "standing our ground." She emphasized Indigenous rights and the need for unwavering commitment to justice and reconciliation. Her words added depth to the discussion on political action and the role of women in advocating for Indigenous communities.

The panel discussed universal pharmacare and Landed Status on arrival. The panelists highlighted how the power of collective action, can and has led to lasting change.

Through inspiring speeches and collective singing, the event celebrated the voices of all women leading the charge for justice, equity, and social change. It was an evening that honoured past achievements while igniting a sense of urgency for the work still needed to achieve gender equity and social justice for all.
