# **BCHC Campaign Call: End Profit** in Long-term Care

Date & Time Selected Sessions:

Oct 31, 2023, 02:00 PM

For-profit long-term care operators are making record profits while under-delivering care hours at alarming rates, and British Columbians – whether residents. family members of residents, or workers in long-term care homes are paying for it.

The current model incentivizes operators to spend less money on care hours, food, and maintenance because they get to turn anything they don't spend into profit. In Billions More Reasons to Care, the BC Seniors Advocate found that over the last five years, for-profit operators made more than seven times the amount of surplus per bed compared to non-profit care The presenters provided graphs operators receiving the same public that demonstrated the disparity in funding.

One of the key recommendations in the report is to improve accountability for taxpayer dollars and ensure funding for direct care is issue, I would encourage you to spent on care.

#### **Vaccines**

Many of you have received text messages saying that you are now eligible to receive Influenza and COVID Vaccines. #### **President's Message**

The Municipal Pension Plan held its Annual General Meeting in October and once again it was a very informative session. I had some challenges logging into the session and did contact the administration as I felt that there should be a simpler way for folks to log in. As has been the past practice, we will be informed in January what our COLA increase will be for 2024. As you may recall, the cap of 2.1%, which had been in place for several years, has been removed so our increase will be more reflective of the current inflation rate. The inflation rate in September was 3.8% and there are few indications that it will be lower in the coming months.
