Pharmacare

Health Minister Mark Holland released the long-awaited details of the federal government's pharmacare plan on Thursday, with a commitment to cover some diabetes treatments and contraception.

If the bill, C-64, passes Parliament, Holland will begin negotiating with the provinces and territories on a funding commitment that would cover the cost of providing these medications to people for free. He said he hopes people can access the program sometime this year, although a lot of uncertainties make an actual start date hard to pinpoint.

The federal government says it also will establish a fund to support Canadian diabetics who need access to syringes and glucose test strips to manage their condition but struggle to afford them.

Tax Time

It is always a good idea to get your taxes done early. This is particularly important for anyone who may be eligible for the GIS as this can be impacted if you do not file on time.

Travel Insurance

Just a reminder for those who are unaware, the medical portion of money spent on travel insurance is tax deductible. Contact your carrier and ask them to separate the medical portion of your cost as the trip cancellation etc. portions are not deductible.

Home Equity Tax issue.

I did write about this issue in a previous edition and have spent some time investigating it further. I'm happy to let you know that it does appear that this is a no starter as the politicians are not willing to take on seniors over this issue.

Free Tax Clinics are available at most Seniors Centres if your return is simple and straight forward.

If you feel that you might want to consider using an accounting firm it's good to know that the cost of having them complete your taxes is a deduction on the following years taxes.

Renters Tax Credit

For the 2023 tax year, the maximum renter's tax credit you may receive is \$400. The credit is reduced by 2% of the amount by which your 2023 adjusted income exceeds \$60,000. The credit is reduced to zero at \$80,000 The adjusted income threshold amount of \$60,000 will be indexed to inflation each year. For the 2024 tax

year, the adjusted income threshold will be increased to \$63,000 and the credit will be reduced to zero at \$83,000. This benefit is applicable for those in housing cooperatives. Earth Day

Earth Day is an annual event on April 22 to demonstrate support for environmental protection. First held on April 22, 1970, it now includes a wide range of events coordinated globally by Earthday.org including 1 billion people in more than 193 countries. The official theme for 2024 is "Planet vs. Plastics." On November 1, 2023, phase 1 of the expanded deposit-refund on aluminum beverage containers came into effect across the province. All existing returnable containers, as well as those used to market aluminum "ready-to-drink" beverages of at least 100 mL and no more than 2 litres, are now refundable at 10 cents each.

For example, a can of your favourite sparkling beverage, with or without alcohol, 473 mL or 355 mL. is now 10 cents. Starting March 1, 2025, the second phase of the depositrefund expansion on glass, plastic and multi-layer beverage containers will come into effect. Phase 2 will apply to all "multi-material" beverage containers from 100 mL to 2 L. In addition, glass beverage containers over 500 mL will be 25 cents each. You'll be able to return your bottles of water or wine for a refund from then on.
